



## Official Rules

### USAgencies Credit Union (USACU) 'Read the Blog to Win' \$50 drawing Effective Feb. 1, 2019 through Feb. 28, 2019.

**How to Enter:** Subscribe to the USAgencies' blog at [blog.usacu.org](http://blog.usacu.org). Each week in February, we will post a blog along with a trivia question at the end of the publication. You will be required to email your answers to each blog post, and the words '**Read the blog to Win**' in the **Subject Line** to [social@usacu.org](mailto:social@usacu.org) by February 28, 2019 and you will be entered to win the \$50 prize. Only one entry per member age 18 and older is allowed. To enter by mail, print your complete name, street address (no P.O. Boxes), city, state, zip code, day and evening telephone numbers, and email address on a 3"x5" note card, and the words '**Read the blog to Win**'. Place the card in an envelope and mail to: USACU, attn. 'Read the Blog to Win', 95 SW Taylor St. Portland, OR 97204. All entries must be emailed or postmarked by 02/26/2019 and received by 03/1/2019. Entrants must be 18 years of age or older. Limit one entry per person.

**Prize Drawing Details:** On 3/4/2019 USAgencies Credit Union will randomly select ONE winner from all eligible entries received for the \$50 prize. The \$50 prize will be deposited into your Membership Share Account at USAgencies Credit Union.
