



Official Rules

USAgencies Credit Union (USACU) 'Snap & Tag Contest' Instagram Contest

Effective April. 1, 2019 through April 30, 2019.

How to Enter: Visit the USAgencies Credit Union branch located at 95 SW Taylor St., Portland, OR 97204 during the month of April and take a picture with the provided cutout in the lobby. You will be required to upload your photo on Instagram and use the hashtag #usacunasnapandtag in the caption of the photo, tag and follow USAgencies Credit Union (@USAgenciesCU). Entrants are required to comply with all respective Social Media platform rules and regulations when posting on Social Media platforms and are prohibited from spamming or creating fraudulent or multiple accounts. Entrants must be 18 years of age or older. Limit one entry per person.

To enter by mail, print your complete name, street address (no P.O. Boxes), city, state, zip code, day and evening telephone numbers, and email address on a 3"x5" note card, and the words **'Snap and Tag'**. Place the card in an envelope and mail to: USACU, attn. 'Snap and Tag', 95 SW Taylor St. Portland, OR 97204. All entries must be emailed or postmarked by 04/28/2019 and received by 05/1/2019. Entrants must be 18 years of age or older. Limit one entry per person. Entrants must provide all information requested to be eligible to win. Incomplete, unreadable, or unintelligible entries will be disqualified.

Prize Drawing Details: On 05/01/2019 USAgencies Credit Union will randomly select ONE winner from all eligible entries received to be eligible for the prize of **a \$50 gas gift card and a golf gift basket (\$70 value)**. The winner will need to travel to the USAgencies Credit Union branch located at 95 SW Taylor St to claim prize. All Federal and state taxes and all other expenses relating to the prizes are the sole responsibility of the winner. No prize substitutions or transfers are permitted except at the sole discretion of USACU. Odds of winning depend on the number of eligible entries received during the promotion period.

Notification: Winner will be notified by direct message on Instagram on or after May 5, 2019. If a selected winner cannot be contacted, is ineligible, or fails to claim a prize, the prize may be forfeited and an alternate winner would be selected. By accepting and/or using the prize, the winner may be asked to agree to the use of his/her name and likeness for the purpose of advertisement, trade, or promotion without further compensation, unless prohibited by law.
